Beckenhauer Road Development Agreement for Big Horn Development Phase two Commissioner Humphreys moved to authorize Chairman Tyler to sign the Road Development agreement that was previously discussed in executive session on 1/19/2022. Honeysuckle Park Road Development Agreement

Director Lenz spoke about requiring Viking Construction to put a 2" overlay on Robison Rd from where the City of Hayden ends and the Highway District picks up on the East to the end of the road West at Carrington. Attorney Susan Weeks spoke about Vikings comments and changes to the agreement and suggests the Board moves to make a motion for the chairman to sign the agreement once it's completed and ready for signature. Commissioner Russell **moved** to authorize the Chairman's signature once the other party signs. Commissioner Humphreys seconded. **Motion carried** unanimously. [2/2/2022 Board Mtg.]

CURRENT BUSINESS

Equipment Purchase of a Vac Broom and Backhoe

Director Lenz spoke about Sourcewell being approved by Idaho Legislation in 2018 to be a public procurement option. Sourcewell has all the vendors submit pricing to them with a percentage off the sticker price. Using Sourcewell saves time because you no longer have to go out to bid.

The Vac Broom Truck is a Schwarze brand. Director Lenz spoke about the benefits of going with a Schwarze vs. the Symco. The District tested the Schwarze and the Symco. The Schwarze takes less passes, has a larger cab and has a side dump.

The backhoe proposed is a John Deere. Director Lenz explained how the John Deere is \$9,000.00 less than the CAT backhoe and for that the Director would like to purchase the John Deere. Commissioner Humphreys expressed his concerns with John Deere equipment due to the fact that there is only one dealership/service center locally and CAT has multiple locations. The board spoke about the differences between the two dealers. Commissioner Humphreys **moved** to pursue the purchase of the CAT backhoe as opposed to the John Deere for the reasons stated. Commissioner Russell seconded. Chariman Tyler was a nay because the cost of the John Deere was \$9,000.00 less. **Motion was 2 to 1.**

Commissioner Russell **moved** to authorize the Director to proceed with the purchase of the Schwarze. Commissioner Humphreys seconded. **Motion carried** unanimously. [2/2/2022 Board Mtg]

Spokane St. Underwater Report

Director Lenz spoke about the results of the report. The shoreline has moderate vegetation, no erosion, heavy accumulation of timber debris. The pilings have active corrosion which indicated the cathodic protection system may not be working. Director Lenz stated the bridge rehab is scheduled for 2024. Commissioner Humphreys mentioned the Cathodic protection system was turned off due to safety issues. Daniel Baker from HDR spoke about the current protection system vs the new approach that's currently being designed for the rehab in 2024. No action required.

MS4 Permit

Director Lenz explained the District received one solicitation from Welch-Comer. Welch-Comer meets all criteria and covered all aspects. Commissioner Humphreys **moved** to enter into the negotiation phase with Welch-Comer for the MS4 permit. Commissioner Russell seconded. **Motion carried** unanimously. [2/2/2022 Board Mtg]

Meyer/ Hayden and Prairie 5 lane Projects

Director Lenz stated that the Meyer/Hayden Roundabout and the Prairie Meyer Rd to SH 41 projects are both ready to move to the design phase. Director Lenz spoke with LHTAC and the District can package projects together when they are starting close together. Commissioner Russell moved to authorize Director Lenz to proceed to **move** forward with packaging both projects. Commissioner Humphreys seconded. **Motion carried** unanimously.
